OVER 100 SAN DIEGO COUNTY CONGREGATIONS AND VOLUNTEERS HAVE COLLECTIVELY SHELTERED MORE THAN 9,900 PEOPLE FOR 270,000 NIGHTS OVER THE PAST 33 YEARS.
